## Manuscript format

AUTHORS ARE ASKED TO KEEP TO THE FOLLOWING GUIDE-LINES

**Authors are strongly encouraged to submit their articles in separate files (text and tables/figures) in Word/Windows.**

The first page must contain the following items:

- Title of the paper
- Author: first NAME in lowercase and SURNAME in capital letters (example: Mario ROSSI)
- COMPANY or INSTITUTION FULL POSTAL ADDRESS, including phone, fax and e-mail address of the corresponding author to whom print proofs should be sent.

### **The Article must contain:**

**Abstract:** in English, also for articles written in Italian language

**Introduction:** the reasons for the research and reference to literature on the same subject

**Experimental part:** with a detailed description of the applied methodology

**Results with discussion**

**Bibliography**

### **If a Review, will must include:**

**comprehensive critical descriptions of present knowledge of actual research subjects or technological developments**

**TEXT** (font: arial, font size: 10)

### **BIBLIOGRAPHY**

The bibliography should be numbered in square brackets (see example).

All references to bibliography must be reported in the text by numbers in square brackets. Where there is more than one reference, each number must be followed by a comma.

*Example:*

[1] C. Rossi, A. Bianchi, Title of the publication. Journal name 73(2), 65-71 (1996)

**DRAWINGS, PICTURES** and **TABLES** (font: arial narrow, font size: 9),

Tables must be numbered progressively with roman numbers.

Pictures (diagrams, figures) with the arabic ones. So also the references in the text.

Drawings, numbers and lines should be well emphasized as all drawings and pictures will be reduced in size to 8 cm (check that, in this size, the internal written are legible).

If drawings are extremely detailed they could be reduced in size to 16.5 cm.

The editorial staff reserves the right to edit the manuscript. Major changes, however, will be made only with authors permission.

Papers publication is free of charge, except:

- a) if the figures have to be redrawn because of poor reproduction
- b) if considerable changes have to be made of the text
- c) if the numbers and/or size of tables exceed the standard agreed on by the Editorial Committee.

Before publication the corresponding author will receive offprint in .pdf file for correction. Corrections must be returned within 48 hours.

After publication of the paper the corresponding author will receive the reprint as a PDF file.
